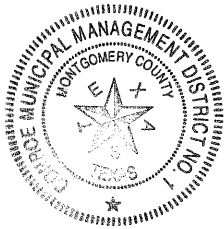
CONROE MUNICIPAL MANAGEMENT DISTRICT NO. 1

 - vi. water, sewer, and drainage to serve Town Park Drive, Phase 2 and water, sewer, and drainages to serve Grand Central Park, Section 13;
 - vii. water, sewer, and drainage to serve Autumn Elm Circle (formerly, Town Center West Loop Boulevard);
 - viii. lift station no. 2 and force main to serve Grand Central Park; and
 - ix. water, sewer, and drainage and paving and appurtenances to serve Grand Central Park, Future Park Site.
- e. LOMR-F for Grand Central Park, Section 17;
- f. Grand Lake drainage impact study.
- g. Bond application no. 2;
- h. Deeds, easements, and utility conveyances; and
- i. Storm water pollution prevention items.

 - i. Grand Central Park, Greenway Village (formerly, Grand Central Park West Village Commercial Tract WV03).

- a. Authorization for design of projects;
 - b. Approval of plans and specifications and authorization for competitive bids or proposals for projects in the service area, including:
 - i. Steetscape Prototype in Town Center;
 - ii. Crescent Campus at I-45 Entry;
 - iii. Bridges at Crescent Campus;
 - iv. Pedestrian Pathway and Bike Circulation on Crescent Campus;
 - v. Crescent Campus Boulevard streetscape; and

- vi. West Village Parks.
- c. Approval of contracts, letter financing agreements, or cost sharing agreements for projects in the service area, including:
 - i. Pathways for West Village, Phase 2;
- d. Approval of pay estimates, change orders, and final inspection as appropriate, for projects in the service area, including:
 - ii. Grand Central Park Streetscapes, including landscape and irrigation to serve Grand Central Parkway from I-45 to Town Park Drive, Crescent Campus from Loop 336 to Grand Central Parkway, and Town Park Drive from Loop 336 to Grand Central Parkway.
- e. Maintenance of park and recreational facilities.
