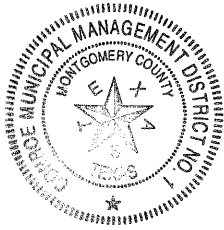
CONROE MUNICIPAL MANAGEMENT DISTRICT NO. 1



 - e. Maintenance of park and recreational facilities.
