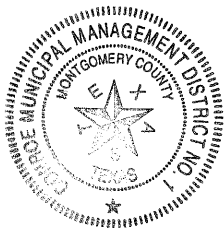
### CONROE MUNICIPAL MANAGEMENT DISTRICT NO. 1

    - iii. Twilight Park and Mystic Pond.
